This Grant Arrangement entered into on March 28, 2006

Between *The Government of Canada* ("Canada") as represented by the Minister for International Cooperation ("the Minister") acting through the Canadian International Development Agency ("CIDA")

And *The United Nations Population Fund* (UNFPA), a legal entity having its Head office/principal place of business at:

New York, USA

FOR THE Prevention and response to sexual violence project in the Democratic Republic of Congo (DRC) at an estimated cost of fifteen million Canadian dollars (CDN\$15,000,000), which has already had the following amendments:

Amendment 1: Dated December 22, 2009 extended the duration of the Arrangement by eighteen (18) months and provided for certain changes to the schedule of payments, without increasing the financial limitation;

Amendment 2: Dated June 17, 2011 extended the duration of the Arrangement by six (6) months, without increasing the financial limitation;

Amendment 3: Dated December 19, 2011, extended the duration of the Arrangement by three (3) months, without increasing the financial limitation;

is hereby amended as follows:

Amendment 4: This amendment extends the duration of the Arrangement by twelve (12) months, increases the financial limitation by three million Canadian dollars (CDN\$3,000,000), and provides for certain changes to Annex A.

Therefore the parties hereto agree on the following:

1 In the Grant Arrangement, **REPLACE 1 Grant**, in its entirety, **WITH** the following:

"1 Grant

1.1 CIDA will make a grant for the purpose of the project described in Annex A ("Project") to this Arrangement in an amount not to exceed eighteen million Canadian dollars (CDN\$18,000,000) ("Grant").

- 2 In the Grant Arrangement, under **3 Payment of Grant**, **REPLACE** 3.1, in its entirety, **WITH** the following:

"3.1 CIDA will make installment payments as follows:

CIDA Fiscal year 2005/06:	\$2,000,000, issued on March 29, 2006
CIDA Fiscal year 2006/07:	\$3,675,000, issued on October 24, 2006 \$1,675,000, issued on March 29, 2007
CIDA Fiscal year 2008/09:	\$3,700,000, issued on February 10, 2009
CIDA Fiscal year 2009/10:	\$1,675,000, issued on October 21, 2009 \$2,275,000, issued on March 23, 2010
CIDA Fiscal year 2011/12:	\$3,000,000, to be issued by March 31, 2012

The anticipated installment payment schedule may be modified if the project delivery warrants and if funds are available from CIDA."

- 3 In the Grant Arrangement, under **7 Duration**, **REPLACE** 7.2, in its entirety, **WITH** the following:

"7.2 This Arrangement will come into effect upon the date of the last signature and will remain in effect until March 31, 2013."

- 4 **REPLACE** Annex A, in its entirety, **WITH** the attached "Annex A Description of the Prevention and Response to Sexual Violence Project (Revised February 2012)".
- 5 All other terms of the Arrangement shall remain unchanged.
