

**Addendum No 2 to the Standard
Administrative Arrangement
between
the Government of Iceland and
the United Nations Population Fund
for the second phase of the Joint Programme on Female Genital
Mutilation/Cutting**

The Government of Iceland (hereinafter referred to as the "Donor") and **the United Nations Population Fund** (hereinafter referred to as "UNFPA") as the Administrative Agent (hereinafter referred to as "the Administrative Agent) of **the second phase of the Joint Programme on Female Genital Mutilation/Cutting** (hereinafter referred to as "the Programme") have agreed as follows:

WHEREAS, Participating United Nations Organizations that have signed a Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have developed the second phase of the Joint Programme, starting on 1 January 2014 and ending on 31 December 2017.

WHEREAS in Section I, Paragraph 1 of the Standard Administrative Arrangement (SAA) concluded between the Donor and the Administrative Agent (hereinafter referred to collectively as the 'Participants") on 12 February 2014, the Donor made a contribution of twenty million three hundred thousand Icelandic krona (ISK 20,300,000 million). The Donor has now agreed to make an additional contribution to the Fund.

The SAA is therefore modified as follows:

Section 1, Paragraph 1: The Donor agrees to make an additional contribution of **21 million Icelandic krona (ISK 21,000,000)** to support the Fund in accordance with the budget and Joint Programme Document.

The Donor will deposit the contribution in USD by wire transfer, in accordance with Section 1, Paragraph 2 of the SAA and the revised Annex B attached hereto, upon request from the Administrative Agent to the following account:
