Amendment 1 to the Standard Administrative Agreement Between The Department of Foreign Affairs, Trade and Development And

This Amendment is made on 4 February between The Department of Foreign Affairs, Trade and Development (DFATD) (hereinafter referred to as the "Donor" and the United Nations Population Fund (hereinafter referred to as "Administrative Agent") for implementation of Participating UN Organizations programmatic activities of the Better Reproductive Health and Rights for All in Indonesia (hereinafter referred to as the "Programme").

WHEREAS the Standard Administrative Agreement (SAA) dated August 8, 2023 (hereinafter referred to as the "Agreement"), the Donor and Administrative Agent have authority to amend the Agreement, and pursuant to such authority wish to amend the Agreement to change the schedule of payment (Annex B).

The Parties agree to amend the Agreement as follows:
