

ADDENDUM NO 1 TO EUROPEAN UNION CONTRIBUTION AGREEMENT No 2024/456-959

second counterparty, (individually a "Party" and collectively the “Parties”), have agreed as follows:

The following provisions of the agreement *Comprehensive Research on Cervical, Breast, Colorectal, and Prostate Cancers for the implementation of Cervical, Breast, Colorectal and Prostate Cancer Prevention Program in BiH*, no. 2024/456-959, concluded between the Contracting Authority and the Parties on 12/08/2024 (the ‘agreement’) are hereby replaced/supplemented as follows:

Article 2 - Entry into Force and Implementation Period

Implementation Period

- 2.2 The Implementation Period of the Agreement (the “Implementation Period”) shall commence on **2nd December 2024**.
- 2.3 The Implementation Period of the Agreement is **12 months**.



Article 3 - Financing the Action

3.1 The total cost of the Action¹ is estimated at USD ("Currency of the Agreement") 1,073,351.00, as set out in Annex III. The Contracting Authority undertakes to provide a contribution up to a maximum of EUR 900,000.00 which is estimated at USD 962,640.00 (the "EU Contribution").

The final amount will be established in accordance with Articles 16 to 18 of Annex II.

Article 7 – Additional specific conditions applying to the Action

7.1.4 VAT/ taxes, duties and charges are not eligible for the activities as described in Annex I.

All other terms and conditions of the agreement remain unchanged. This addendum shall enter into force on the later date of signature by the parties.

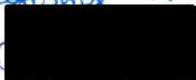
