

ADDENDUM NUMBER 1 TO AGREEMENT BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND UNFPA CONCERNING QZA-20/0135 "UNFPA-UNICEF JOINT PROGRAMME TO ELIMINATE FEMALE GENITAL MUTILATION: DELIVERING THE GLOBAL PROMISE TO END FGM"

WHEREAS the Norwegian Agency for Development Cooperation (Norad) and UNFPA (the Partner) (jointly referred to as the Parties) have entered into an agreement dated 6 October 2022 (the Agreement) concerning QZA-20/0135 "UNFPA-UNICEF JOINT PROGRAMME TO ELIMINATE FEMALE GENITAL MUTILATION: DELIVERING THE GLOBAL PROMISE TO END FGM"] (the Project), and

WHEREAS the Partner in a letter dated 8 June 2023 has requested additional financial support to the Project, with which Norad has decided to comply,

NOW THEREFORE the Parties have reached the following understanding, which shall constitute Addendum number 1 to, and be an integrated part of, the Agreement:

1 ADDITIONAL GRANT

- 1.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, and this Addendum, provide an additional grant not exceeding NOK 12 000 000 (twelve million Norwegian Kroner) (the Additional Grant).
- 1.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget included as Annex A to this Addendum, during the Support Period.
- 1.3 The Additional Grant shall be upon signing of this Addendum.

2 REMAINING CONDITIONS OF THE AGREEMENT

- 2.1 All other provisions of the Agreement shall remain unchanged and in force.

3 ENTRY INTO FORCE AND DURATION

- 3.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.

IN WITNESS WHEREOF the undersigned, acting on behalf of their respective Party, have signed the Addendum in two -2- originals in the English language, whereof the Parties keep one each. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
