Executive summary

For the year 2013, UNFPA's contraceptive offer is composed by **34 ITEMS**¹ grouped in **9 SUB-CATEGORIES**.

The total procurement spend is \$150,775,375.97 for a total of 991 orders.

The ITEM with the highest procurement spend was **CONDOM 53 STANDARD** with \$26,726,454.00 that is equal to 17,7% of the total spend in 2013. In 2012 the top ITEM was IMPLANON and in 2013 IMPLANON was the second most procured item with \$25,396,776.28.

The ITEM with the lowest procurement spend was **CONDOM54STANDARD** with a procurement of only \$3,003.00, representing a 0.00001% of the total procurement spend. In 2012 the item with the lowest procurement spend was **CU375STTYVEK**, which is not an ITEM ID in 2013 anymore.

The CATEGORY with the highest procurement spend was **SUBDERMAL IMPLANTS** with **\$49,467,076.28**, 33% of the total procurement spend in 2013. In 2012 the category with the highest spend was also SUBDERMAL IMPLANTS, with **\$50,266,600.00**. The spend in this category has decreased by 1.6%.

The CATEGORY with the lowest procurement spend was **LUBRICANTWATER** with \$406,417.06, representing 0.3% of the total procurement spend in 2013. In 2012 the category with the lowest spend was **EMERGENCY CONTRACEPTIVES** with **\$154,773.44**.

Subdermal Implants, with \$49,467,076.28 that is equal to 32.8% of the total procurement spend, is the 1st category in terms of procurement spend and it is composed by 2 ITEMs.

Injectable contraceptives, with \$35,685,717.13 that is equal to 23.7% of the total procurement spend, is the 2nd category in terms of procurement spend and it is composed by 7 ITEMS.

Male Condoms, with \$29,639,764.20 that is equal to 19.7% of the total procurement spend, is the 3rd category in terms of procurement spend and it is composed by 10 ITEMs.

Combined Low Dose OC Pills, with \$16,928,094.45 that is equal to **11.2% of the total procurement spend**, is the **4**th **category in terms of procurement spend** and it is composed by **4 ITEMs**.

Female Condoms, with \$11,200,510.00 that is equal to 7.4% of the total procurement spend, is 5th category in terms of procurement spend and it is composed by 1 ITEM.

Progestagen Only Pills, with \$5,354,723.71 that is equal to 3.6% of the total procurement spend, is the 6th category in terms of procurement spend and it is composed by 2 ITEMs.

Intra Uterine Devices, with \$1,203,255.64 that is equal to 0.8% of the total procurement spend, is the 7th category in terms of procurement spend and it is composed by 4 ITEMs.

Emergency contraceptives, with \$889,817.50 equal to 0.6% of the total procurement spend, is the 8^{th} category in terms of procurement spend and it is composed by **2 ITEMs**.

Lubricants, with \$406,417.06, which is equal to 0.3% of the total procurement spend, is the 9th category in terms of procurement spend. It is composed of **3 ITEMs**, but due to the low procurement spend and to the similarity between the single ITEMs, in this report they are going to be **considered** as **1**.

The country with the highest procurement spend was UGANDA with \$11,120,573.50, equal to 7.4% of the total spend in 2013. In 2012 the country with the highest procurement spend was ETHIOPIA with \$15,203,607.55, equal to 12% of the total spend in 2012.

The country with the lowest procurement spend was BANGLADESH with \$2,850.00, equal to 0.002% of the total spend in 2013. In 2012 the country with the lowest procurement spend was TURKMENISTAN with only \$4,046.00, equal to 0.003% of the total.

Africa is the Region with the highest overall procurement spend and it is also the region with the **highest procurement spend in 5 out of 9 categories**². Together, the 2 top spending categories for Africa region, INJECTABLES CONTRACEPTIVES and SUBDERMAL IMPLANTS sum up to 62% of the total procurement spend in Africa in 2013 and 38% of the total spend in 2013.

For the year 2013, PSB STOCK was composed by **4 ITEMS** each belonging to a different CATEGORY, **MALE CONDOMS, FEMALE CONDOMS, IUDs and INJECTABLE CONTRACEPTIVES**. The total procurement spend for PSB STOCK was **\$9,278,287.00** that is equal to **6.2% of the total spend in 2013**.

Bayer Pharma AG is the vendor that receives the highest amount of procurement value with \$33,289,548.79 equal to 22.1% of the total procurement value.

For the year 2013, UNFPA's contraceptive offer is composed by **34 ITEMS**³ grouped in **9 SUB-CATEGORIES**.



Figure 2: Variation in the total number of POs by category



By Item

The item with the highest procurement spend is CONDOM 53 STANDARD, with \$26,726,454.00, equal to 17.7% of the total spend in 2013. In 2012 the item with the highest procurement spend was IMPLANON with \$25,388,100.00 that was equal to 20% of the total spend in 2012. In 2013 IMPLANON is the second item with highest procurement, with \$25,396,776.28 – almost the same value as the previous year.

The item with the lowest procurement spend in 2013 is CONDOM 54 STANDARD with only \$3,003.00, equal to 0.002% of the total procurement spend. In 2012 the item with the lowest procurement spend was CU375STTYVEK with only \$176.00 that was equal to less than 0.0001% of the total procurement spend. This item does not exist in 2013 anymore, but the second lowest item in terms of procurement is also an IUD, CU375STPOLYMER, with \$4,988.00.

The ITEM with the highest number of POs was JADELLE in 2013, with 125 orders, representing 12.6% of the total procurement orders. In 2012 the item with the highest amount of orders was SYRINGESOLO1ML with 107 that are equal to 12% of the total. In 2013 this item was the second in number of orders, after JADELLE, with 118 orders.

The category with the highest procurement spend was SUBDERMAL IMPLANTS with \$49,467,076.28 and 171 orders, this represents 32.8% in terms of procurement spend and 17.3% of the total number of orders. In 2012 also SUBDERMAL IMPLANTS was the category with the highest spend, with \$50,266,600.00 that was equal to 40% of the total spend in 2012.

The category with the lowest procurement spend in 2012 was EMERGENCY CONTRACEPTIVES with \$154,773.44 that was equal to 0.12% of the total procurement spend of 2012.

The category with the highest number of POs was INJECTABLE CONTRACEPTIVES, with 275 orders, representing 27.7% of the total orders for 2013. In 2012 the category with the highest number of POs was also INJECTABLES CONTRACEPTIVES with 251 orders that were equal to 29% of the total orders for 2012. The procurement of injectables has increased however from 2012 to 2013 by almost 30% in value and 10% in number of POs.

The category with the lowest number of POs was LUBRICANTS, with only 36 POs, 3.6% of the total number of POs in 2013. In 2012, the category with the lowest number of POs was also LUBRICANTS with 20 POs that is equal to only 2% of the total 2012 POs. The procurement of Lubricants has, however, increased from the previous year by almost 13% in terms of value and by 80% in the number of orders.

This category, with \$49,467,076.28 that is equal to 33.8% of the total procurement spend, is the 1st category in terms of procurement spend and it is composed of 2 ITEMs.

IMPLANON, which is procured from MSD OS, with \$25,396,776.28, is the ITEM with the 2nd highest procurement spend. JADELLE, which is procured from BAYER SHERING PHARMA OY, with \$24,070,300.00, is the 3rd ITEM with the highest procurement spend.

This category, with \$35,685,717.13 that is equal to 23.7% of the total procurement spend, is the 2nd category in terms of procurement spend and it is composed by 7 ITEMS.

DMPA_DEPO, which is procured from PFIZER, with \$18,757,876.88 is the Injectable contraceptive that is procured the most.

Injectable contraceptives are procured in all regions.

Africa is the region which procures the highest amount with \$22,115,833.13 that is equal to 62% of the total procurement spend for injectable contraceptives.

This category, with \$29,639,764.20 that is equal to 19.6% of the total procurement spend, is the 3rd category in terms of procurement spend and it is composed by 10 ITEMs.

CONDOM53STANDARD, which can be procured from 14 different suppliers, and with a spend of \$26,726,454.00 is the 1st item in terms of procurement spend and it is the condom that is procured the most.

Figure 3: Procurement Volume by vendor




